he Oregon Bird Records Committee, or OBRC, recently celebrated its 40th birthday. Founded in 1978, the committee stays true to its original aim of collecting, reviewing, and maintaining records on rare birds found in Oregon, in an ever-changing landscape.

# New Species for Oregon: Eurasian Skylark

One new species was added to the Oregon state list this year: Eurasian Skylark. This brings the total species list to 537. Oregon's first Eurasian Skylark was seen and photographed in Lincoln County at Newport's south jetty, November 16, 2017, by Russ Namitz and soon thereafter identified by Adrian Hinkle. The subspecies of this bird remains unidentified, as documentation after the discovery date consisted primarily of fuzzy flight shots and a sound recording. It didn't help that the bird only stuck around for one additional day and was rather skittish. One explanation as to the bird's provenance is that it originated from somewhere in eastern Asia before making the heroic journey to Oregon. Another possible explanation is that it was a stray from Vancouver Island, British Columbia, where there exists an established population of Eurasian Skylarks.

# Mystery "Hegrets"

Two mystery birds, nicknamed "hegrets" (heron/egret), discovered at the Narrows, Malheur NWR, Harney Co., had everyone guessing. Hundreds of photos and videos were taken, and many experts were consulted. In the end, the general consensus was that these birds were hybrids, possibly even nest mates. Two possible hybrid combinations include Little Blue Heron X Snowy Egret and Cattle Egret X Snowy Egret (records 200-17-15 and 200-17-16, both submitted as Little Blue Heron and Not Accepted as such). It is not often that one, let alone two birds, can be so well documented and studied, and yet not be definitively identified. This prompted the Committee to open a discussion at the Annual Meeting on how best to review hybrids. It was decided that hybrids will be reviewed if both putative parent species are themselves Review List species, or in the rare exception (as these two birds were), the hybrid is particularly confounding and potentially involves a review species.

# OBRC Annual Meeting - March 10, 2018

This year's Annual Meeting was held at Heron Hall, located inside the Audubon Society of Portland. Member participation was high, with only one member and one alternate absent. In between the sounds of workers remodeling the exterior of the

The Oregon Bird Records Committee reviews and votes on a batch of records every 60 days.

During first-round voting, Committee members act independently and do not consult one another. If a record is Accepted at this stage by all nine Committee members, it is added to the state records. If, however, there is at least one "Not Accepted" vote, the record is opened up to discussion. After discussion, the Committee votes again.

If, in second-round voting, a record receives no more than one Not Accepted votes, it is accepted and added to the state records. If it receives two or more Not Accepted votes, it is then held until the next Annual Meeting for more review and a final decision.

This process means that some records can be completed within two months of submission, but others may take several months.

# Third Round Records

Per the rules of the Committee, submitted records that are neither accepted nor declined after two rounds of voting move on to a third round of voting, done in person at the Annual Meeting. As all of the voting on first- and second-round records takes place online, it is a distinct change of pace to have the debate conducted in person and in the span of several minutes instead of two months. Each of these records was discussed at length before the Committee voted the old-fashioned way: by raising hands in the air.

# **Revisiting Prior Records**

It was brought to the Committee's attention that, with new information on bird movements available through sources such as eBird, several state records committees, including Washington's, have been re-reviewing many "sight only" historical records. The Committee discussed the logic, need, and protocol behind revisiting and re-voting on existing records. Most members were in agreement that some "sight only" records, especially ones dealing with first state records and/or those that have yet to be properly documented in the state of Oregon, were candidates for review. The Committee determined that there was time to revisit only two historical records during the meeting, both of which dealt with the same species, Painted Redstart, but that other records should be re-reviewed at a later date. Records 688-90-02 and 688-91-03 were re-voted on, with the former record receiving a vote of NOT ACCEPTED, and the latter remaining ACCEPTED.

# Least Bittern and Upland Sandpiper

The Review List for OBRC was increased this year, but not for the expected reason. The Committee is now requesting that records of Least Bittern and Upland Sandpiper, both species that have had a sharp decline in the number of documented field reports over the past several years, be submitted to the OBRC. Least Bitterns may still be lurking in hard-to-access traditional haunts, but Upland Sandpipers seem to be all but extirpated in the state.



# Records

From March 2017 until March 2018, the committee reviewed 56 records, of which, 46 records were accepted and 10 were not. These records are presented in the next two pages. Following each species name is the OBRC file number, which can be read as follows: The first three digits are the AOU number for that species; the second two digits are the year in which the bird(s) was observed; and the last two digits represent the consecutive number of records of that species that have been submitted to the OBRC.
