

Oregon Bird Records Committee: 2024 Report

The Oregon Bird Records Committee finalized review of a total of 65 records in 2024, all of which were first-time submissions. Of these, 55 records were accepted and 10 were not accepted. Most submissions (58, or 89.2%) were supported either by photos (55) or sound records (3), and 53 of these 58 records (91.4%) were accepted. Of the seven sight-only records reviewed, two (28.6%) were accepted. The 10 records not accepted included five accompanied by photos and five sight-only submissions.

The county breakdown of accepted records shows that the most records were from Curry County with 10 accepted records, followed by Clatsop County with eight, Harney County with seven, Coos County with six, and Tillamook and Lincoln counties with five each. Union and Multnomah counties had three each, while Lane and Jackson counties had two each. Benton, Josephine, Klamath, and Lake counties each had one.

Highlights for the year included an unprecedented eight Orchard Oriole records, all but one of which were found in the fall of 2023 or the winter of 2023-2024. An impressive four Nazca Booby records were noted; this continues a trend for increased sightings of Nazca Booby (and other booby species) along the West Coast in recent years, likely due to altered marine conditions related to climate change. Other highlights included Oregon's second Dusky-capped Flycatcher, second Bell's Vireo, third White-eyed Vireo, third and fourth Winter Wrens, and fourth Lucy's Warbler. Tim Rodenkirk personally found 11 review species that were accepted by the OBRC in 2024.

The Committee added two species to the Oregon state list in 2024: Blue Rock-Thrush and Siberian Pipit. The Blue Rock-Thrush record is one of only three accepted records of this species in North America. An account of the discovery of the Blue Rock-Thrush can be found in *Oregon Birds* 50(1): 8–11. Siberian Pipit was split from American Pipit by the American Ornithological Society in 2024. The Committee has now accepted two records of Siberian Pipit, one from 2019 and one from 2022.

One species was removed from the state list in 2024: Hoary Redpoll was lumped with Common Redpoll and Lesser Redpoll into a single species, Redpoll, by the American Ornithological Society in 2024.

Through the end of 2024, Oregon's state total stood at 548 species, behind only California (689), Texas (672), Arizona (570), and New Mexico (555).

RECORDS NOT ACCEPTED

Chimney Swift CHSW-2023-07

Kiger Gorge, Steens Mountains, Harney County, Sep 6, 2023. The Committee felt that the photos and the video provided were not adequate to eliminate Vaux's Swift. The bird was not heard vocalizing.

“Vega” Herring Gull HERG-2023-09

Coffin Butte Landfill, Benton County, Nov 21, 2023. The Committee deemed that the photos of this bird and the written description were inadequate to establish the bird's identification. The bird was seen at some distance, which made high-quality photos difficult to obtain. Lighting conditions may have also been a factor.

Nuttall's Woodpecker NUWO-2024-04

Arlington, Gilliam County, Sep 22, 2024. The Committee judged that the photos were those of a Downy Woodpecker.

Plumbeous Vireo PLVI-2024-24

3.1 miles up Pike Creek, Harney County, May 26, 2024. The Committee concluded that the photos and audio files provided did not eliminate Cassin's Vireo.

Phainopepla PHAI-2022-15

Denman Wildlife Area, Jackson County, Aug 2, 2024. The Committee felt that the description was not detailed enough to eliminate other similar species.

Blue Rock-Thrush BRTS-2024-02

Seaside, Clatsop County, Jan 2024. The Committee felt that the description was incomplete and that it did not rule out other species.

Blue Rock-Thrush BRTS-2024-03

Roseburg, Douglas County, Mar 6, 2024. The Committee judged that the photo was that of a Western Bluebird.

Prothonotary Warbler PROW-2023-12

Hospital Hole trail, Tillamook, Tillamook County, Jun 18, 2023. The Committee thought that the description was not quite adequate to positively identify this bird as a Prothonotary Warbler. The Committee also felt that it would be quite improbable for a Prothonotary Warbler to perch atop a 30-foot-tall tree.

Kentucky Warbler KEWA-2024-07

Devils Elbow State Park, Lane County, Jul 8, 2024. The Committee concluded that the description was not adequate to eliminate similar species.
